Board of Supervisors  
Meeting Minutes, September 9, 2013

- CALL TO ORDER** The West Pike Run Township Board of Supervisors met in regular session on Monday, September 9, 2013. The meeting was called to order at 6:30 p.m. by Chairman Richard Molish.
