

ORDINANCE NO. 2016-4

**WEST PIKE RUN TOWNSHIP
WASHINGTON COUNTY, PENNSYLVANIA**

AN ORDINANCE OF WEST PIKE RUN TOWNSHIP, COUNTY OF WASHINGTON, COMMONWEALTH OF PENNSYLVANIA, PROVIDING FOR THE REGULATION OF STOPPING AND PARKING VEHICLES ON CERTAIN ENUMERATED STREETS IN THE TOWNSHIP, AND PROVIDING THE PENALTIES FOR VIOLATION THEREOF.

WHEREAS, under 75 Pa. C.S.A. Section 3353, the Township may restrict or prohibit parking on certain designated streets within the Township, and therefore;

BE IT ENACTED AND ORDAINED by the Board of Supervisors of the Township of West Pike Run, Washington County, Pennsylvania, and it is hereby enacted and ordained by the authority of same that there shall be no parking on the roads of Circle (T-461) and Main Street (T-459) as designated in the Plan of HMT and Associates, September 27, 2016 which is attached to this Ordinance.

PENALTIES: Any person violating any provision of this Ordinance is guilty of a summary offense and shall, upon conviction, be sentenced to pay a fine of not more than Fifty (\$50.00) Dollars.

Separability and Savings: If any section or provision of this Ordinance is adjudged by a Court of Competent Jurisdiction to be unlawful, void, or unenforceable, all the remaining sections and provisions of this Ordinance shall remain in full force and effect.

Effective Date: This Ordinance shall become effective and be enforced from and after its approval as provided by law.

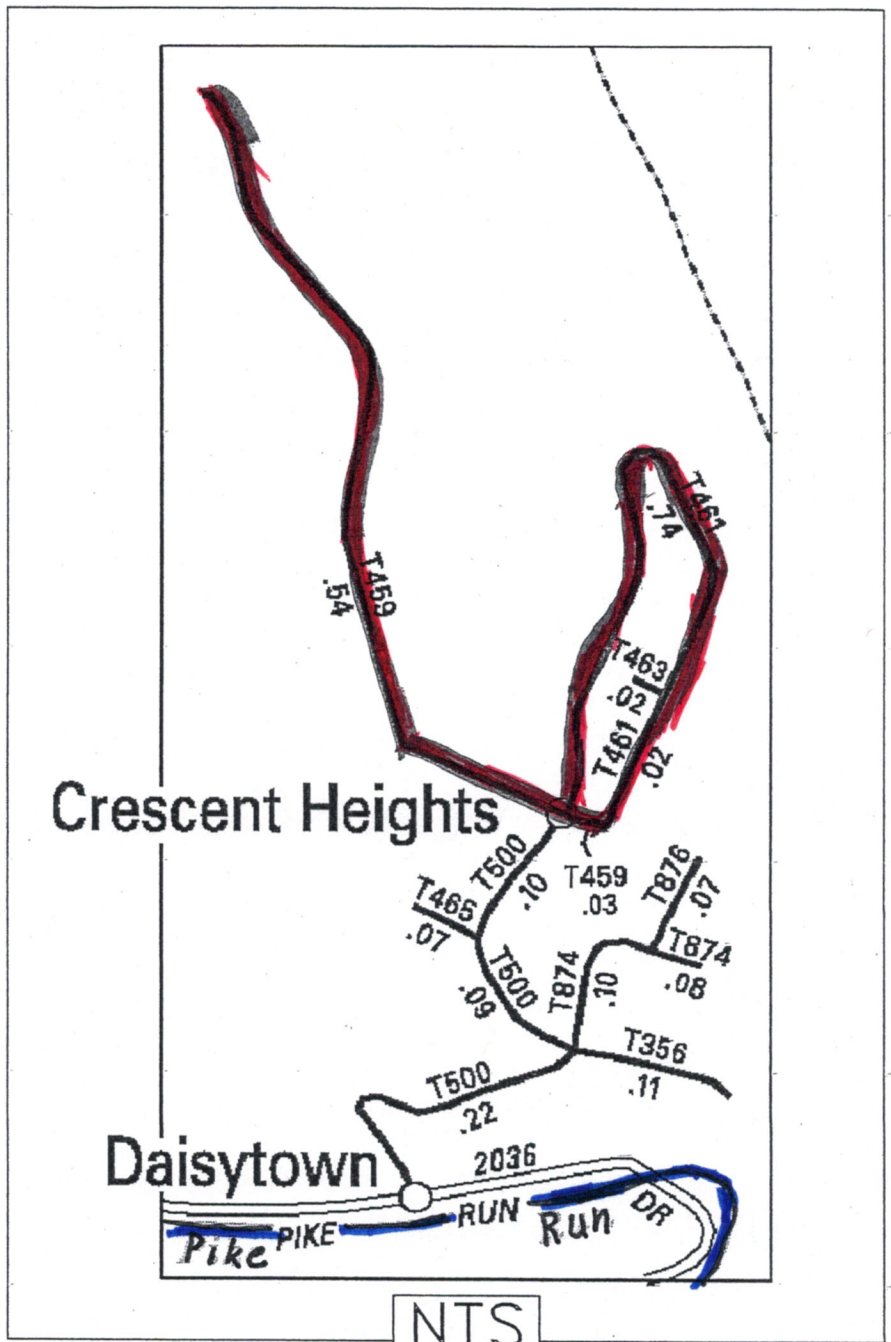
