

ORDINANCE NO. 2 OF 2017

TOWNSHIP OF WEST PIKE RUN
WASHINGTON COUNTY, PENNSYLVANIA

**AN ORDINANCE OF THE TOWNSHIP OF WASHINGTON COUNTY
SETTING FORTH CERTAIN GUIDELINES AND LIMITATIONS FOR
THE COMPENSATION OF THE SUPERVISORS OF THE TOWNSHIP OF
WEST PIKE RUN OF WASHINGTON COUNTY, PENNSYLVANIA, A
SECOND CLASS TOWNSHIP.**

WHEREAS, the Commonwealth of Pennsylvania has enacted Act 60 of 1995 effective on December 28, 1995, amending the Second Class Township Code; and,

WHEREAS, one of the purposes of said legislation is to set forth certain guidelines and limitations for the compensation of Supervisors of Townships of the Second Class; and,

WHEREAS, the aforesaid Act provides that Supervisors of Second Class Townships having a population of, not more than Four Thousand Nine Hundred Ninety-nine (4,999) may be compensated in an amount not to exceed One Thousand Eight Hundred Seventy-five (\$1,875) Dollars; and

WHEREAS, the population of the Township of West Pike Run is approximately One Thousand Seven Hundred Forty-nine (1,749) as of Census Bureau Data released in December of 2016; and

WHEREAS, the Township previously enacted a guideline setting forth the compensation of Supervisors and is unable to locate such ordinance; and

WHEREAS, the General Assembly by said Act 60 of 1995 authorizes the Board of Supervisors of the various townships of the Second Class to determine the compensation of said Supervisors subject to the limitations set forth in said Act.

NOW THEREFORE, pursuant to the authority conferred upon it by the Pennsylvania Second Class Township Code, the Board of Supervisors of the Township of West Pike Run, Washington County, Pennsylvania, do hereby enact and ordain the following:

SECTION 1. SHORT TITLE

This Ordinance shall be known as the Township of West Pike Run "SUPERVISORS" "COMPENSATION ORDINANCE".

SECTION 2. PURPOSE

The Purpose of this Ordinance is to reaffirm a schedule of compensation for the Supervisors of the Township of West Pike Run.

SECTION 3. SUPERVISORS' ANNUAL COMPENSATION

Each Supervisor of the Township of West Pike Run elected or appointed to office shall receive compensation for attending duly advertised general or special public meetings or hearings of the board of Supervisors, or other meetings authorized by the Board of Supervisors at the rate of Twenty Five (\$25) for the aforesaid, not to exceed One Thousand Eight Hundred Seventy-five (\$1,875) Dollars per year.

SECTION 4. COMPENSATION PAYMENT SCHEDULE

Such compensation shall be paid in monthly or quarterly installments.

SECTION 5. REPEALER

Any ordinance containing any provision inconsistent herewith to the extent that such provision is inconsistent, that provision, is also hereby repealed.

SECTION 6. SEVERABILITY

If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal, or invalid, such unconstitutionally, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance. It is hereby declared as the intent of the Board of Supervisors that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.

SECTION 7. EFFECTIVE DATE

This Ordinance shall become effective immediately upon final enactment.
