## **WEST PIKE RUN TOWNSHIP**

Board of Supervisors Meeting Minutes, January 7, 2013

CALL TO ORDER

The West Pike Run Township Board of Supervisors met in regular session on Monday, January 7, 2013, immediately following the reorganization meeting.

PLEADGE & ROLL CALL

Present at the meeting were Supervisor Rick Molish, Supervisor Phil Podroskey, Supervisor Laura Hough, Manager, Erin Sakalik and Solicitor, Herman Bigi.

PUBLIC DISCUSSION

Jack O'Neil commented on the compressor station at the Tomsic property. He is concerned about drainage going into the creek. Rick informed that he will call the DEP.

Dan Russell opined that there should be someone from the Township who watches the gas well companies for compliance of Township matters. He was advised that the code enforcement officer would be the person to make sure the companies are in compliance. Dan suggested that this was a conflict of interest since Mike Hardesty works for a gas well company. He then spoke about the speeding trucks on his road.

John Farkas expressed concern over Hickory Road being blocked by well traffic.

Jack O'Neil told the Board that they need to appoint someone to watch the gas companies.

<u>Electronics Recycling Center.</u> Erin explained the new electronic recycling law that went into effect on January 1. The township will now provide two recycling containers for residents to dispose of their electronics. Residents may use the containers during Township office hours.

<u>Part-time Police Officer</u>. Motion carried to advertise for a part-time police officer. RCV: Hough – Yes, Podroskey – Yes, Molish – Yes.

<u>Resolution 506</u>. The Chairman asked for a motion to adopt Resolution 506, establishing the tax rate for 2013. Laura made a motion to adopt Resolution 506, motion seconded by Rick. RCV: Phil, yes, Rick, yes, Laura, yes.

Ordinance 2013-1. Motion carried to adopt Ordinance 2013-1 adopting the provisions for the nonuniform pension plan. RCV: Phil, yes, Rick, yes, Laura, yes.

OTHER BUSINESS

Mt. Zion Baptist Church. Motion carried to exempt the church from paying light and hydrant tax. RCV: Phil, yes, Rick, yes, Laura, yes.
