

ORDINANCE NO. 22017

TOWNSHIP OF WEST PIKE RUN  
WASHINGTON COUNTY, PENNSYLVANIA

AN ORDINANCE SIGNIFYING THE DESIRE AND INTENTION OF WEST PIKE RUN TOWNSHIP, WASHINGTON COUNTY, PENNSYLVANIA, TO ORGANIZE A MUNICIPAL AUTHORITY, UNDER THE MUNICIPALITY AUTHORITIES ACT OF 1945, DESIGNATED AS ACT NO. 164, APPROVED MAY 2, 1945, THEREOF, AND AMENDED THERETO, FOR THE PURPOSE OF OWNING AND MAINTAINING A WATER TREATMENT AND CONVEYANCE SYSTEM OR OTHERWISE PROVIDING THE FACILITIES NECESSARY TO FURNISH WATER TREATMENT FOR A SECTION OF WEST PIKE RUN TOWNSHIP AND SUCH ADJOINING POLITICAL SUBDIVISIONS AND AREAS AS MAY BE RECEIVING OR SHALL BE RECEIVING SUCH SERVICES; SETTING FORTH THE PROPOSED ARTICLES OF INCORPORATION IN FULL; DEFINING THE PURPOSES AND POWERS OF SAID AUTHORITY; AND AUTHORIZING THE PROPER OFFICERS OF THE SAID TOWNSHIP TO DO ALL THINGS REQUISITE FOR THE ORGANIZATION OF AN AUTHORITY UNDER THE SAID ACT.

**WHEREAS**, it is the desire of West Pike Run Township, Washington County, Pennsylvania, to organize a Water Authority under the provisions of an Act of Assembly, May 2, 1945, P.L. 382, as amended; and

**WHEREAS**, it is now deemed necessary for the protection of the health, cleanliness, comfort and safety of the citizens of West Pike Run Township to enact this ordinance; and

**NOW, THEREFORE**, pursuant to the authority coffered upon it by Pennsylvania Second Class Township Code and the Municipality Authorities Act of 1945, it is hereby ordained and enacted by the Board of Supervisors of West Pike Run Township, Washington County, Pennsylvania, as follows:

**SECTION 1. SHORT TITLE**

This Ordinance shall be known and cited as the “West Pike Run Township Water Authority Incorporation Ordinance”.

**SECTION 2. INTENTION TO ORGANIZE AUTHORITY**

It is the desire and intention of West Pike Run Township, a Second Class Township of the Commonwealth of Pennsylvania, and situated in Washington County, to organize an Authority under the “Municipality Authorities Act of 1945”, designated as Act No. 164, approved May 2, 1945, together with all supplements thereof, and amendments thereto, for the purpose of exercising and enjoying all the powers of the Act or as amended.

**SECTION 3. NAME OF AUTHORITY**

The name of the proposed Authority is West Pike Run Township Water Authority.

**SECTION 4. ARTICLES OF INCORPORATION**

The proposed articles of incorporation of the Authority in full are as follows:

In compliance with the Municipality Authorities Act of 1945, its supplements and amendments, of West Pike Run Township, situated in Washington County, Commonwealth of Pennsylvania, pursuant to this ordinance duly adopted by the Township signifying its desire and intention to form an Authority, hereby certifies:

1. The name of the Authority shall be “West Pike Run Township Water Authority”.
2. The Authority is formed under the Act of General Assembly of the Commonwealth, which was approved the 2<sup>nd</sup> day of May 1945, P.L. 382, as amended.
3. No other Authority organized under the Act or under the Act approved the 28<sup>th</sup> day of June 1935, P.L. 463, is in existence or for the said incorporating municipality except the following: West Pike Run Municipal Authority.
4. The purpose of the Authority is to construct or otherwise provide the facilities necessary to furnish water for the incorporating municipality and to such adjoining political subdivisions or areas as desire the service.

5. The respective name of the incorporating municipality is West Pike Run Township.
6. The names and addresses of the Board of Supervisors of West Pike Run Township are:

7. This Authority is created to cover West Pike Run Township, the area adjacent thereto and any property which can be incorporated into said area for the purposes hereinafter set forth.
8. The name of the incorporating municipality is West Pike Run Township and its address is 238 Pike Run Drive, Daisytown, Pennsylvania 15427. The names and addresses of its municipal authorities are as follows:
  - a) West Pike Run Municipal Authority, PO Box 222, Daisytown, PA 15427, engaged in providing sewage disposal for the township of West Pike Run and adjacent areas.
9. The membership of the Board of the Authority shall be chosen by the Board of Supervisors of West Pike Run Township.
10. The names, addresses and terms of office of the members of the board of said Authority are:

11. West Pike Run Township retains the right under the Municipal Authorities Act of 1945 as amended, when necessary to approval any plan of the West Pike Run Township Water Authority.

**SECTION 5. EXECUTION OF ARTICLES OF INCORPORATION**


The Articles of Incorporation of the Authority, in substantially the form set forth in Section 4 of this Ordinance, shall be executed on behalf of West Pike Run Township and under its municipal seal, attested by Secretary/Treasurer of West Pike Run Township, and on behalf of West Pike Run Township by the Chairwoman of the Board of Supervisors and such officers are hereby authorized, empowered and directed to do all things necessary and appropriate to effect and establish the said Authority, in conformity with the “Municipal Authorities Act of 195”, its supplements and amendments.

**SECTION 6. SEVERABILITY**

Should any portion of this Ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, the remainder of this Ordinance shall not be affected. It is hereby declared that the intent of West Pike Run Township is that this Ordinance would have been adopted at such unconstitutional illegal or invalid sentence, clause, section or part thereof not been included herein.
