CALL TO ORDER

Paul Becka- Discussed Article from Observer Reporter June 9<sup>th</sup> 2018, "Ruling Highlights Importance of local Zoning rules on oil and gas". Read several statements from the Article. In closing he stated he believes the article was trying to say is we have to take into consideration the land use. It's industrial event, industrial organization versus environment in residential area, agricultural area and what the impact of that well is on residence in that community.

Connie Palfrey- Wanted to reiterate looking at the dimensions of the three different parts

Of that well pad wanted to make sure you realize how big those are. They
are Permitting 67 acres they are going to disturber 37 acres so I 'am asking you
make any set back from the edge of any pad and not the well head. She also
asked about the executive session held for discussion on the Oil and Gas
Ordinance. She asked if there is any rule stating you have to discuss
ordinances in public. Dennis Makel responded that he has litigated this before
that When it comes to zoning and things to that nature council can have
deliberations concerning decisions to be made by council because we did have
a number of hearings.

Maria Ziolecki- Was asking about the permit for Carson Pad concerning the Scope and size.

Maria question was as we talk about the ordinance and zoning and weather it industrial use versus Agricultural use the definition of industrial use is related to industry so if you strictly look it up in dictionary it industrial land use. As we look at map and see how close it will be located to existing pads how can we pursue some kind of density limitation because you're talking about Super Well pad that is very close to other very large oil and gas operations'. If they can drill as far horizontally as we heard what the need for that well Pad?

- Joyce Cherok- Gave update on the Paul Selestow. The Judge gave him 30 days to clean it up.

  Dennis Makel explained that the township has two options if the junk isn't
  Remove. First the township can file a citation every day after the 30 days that
  The junk isn't clean up. Second is to file action of inequity. She showed the
  Board letter she receiver in her mail box concerning Oil and Gas. She requested
  that who ever is distributing letter do it legally.
- Glenn Hurley- stated that has same goal as other residents that have spoken and that's the safety of the residence.
- Colleen Tiberie- Talked about the article in Observer Reporter that Paul Becka presented. Also Mentioned the Mark West being fined and the agreements that came out of it. One of them being Air Monitoring Station upwind and Downwind from their Harmon Creek Compressor station. Dennis Makel responded that he is looking into the new air quality regulations covering the methane and try to incorporate them into the new ordinance. Also stated that the Gate at the Mad Dog site is being left open and unsecure. Mr. Makel state he will sending a letter notifying them about the gate.
- Dale Tiberie- Want to say he agrees with everyone else in regards to the zoning. Doesn't think Should have anymore pads developed in township till we see what's going on With the emission in the state next August. Believes the zoning for the pads Should be compatible with the comprehensive plan.
- Walter King- Stated that he believes that they put small fences around certain areas. But was Concerned seen two people walking around the site with rifles doesn't know what they could do there, what kind of damage can be done. Stated there is no gate. Also asked about a helicopter flying over the sites, wanted to know if have notifying township if they do something like that. Asked about weight limit signs on McGirt's bridge.
