  Dep takes Precedence. Other townships had been sued, Because they
  Put in Ordinance stronger then state. If we ask for something currently
  Stronger then state allows we can get sued as a township and we have no
  Money. She stated that this can't be any stronger then the state law already.
  Solicitor Makel stated that thru Act 13 Municipalities have the right thru land
  Use to put forth certain parameters in terms of zoning.
