CALL TO ORDER

The West Pike Run Township Board of Supervisors met in regular session on Monday, March 18th, 2019. The meeting was called to order at 6:30 by Chairlady Laura Hough.

Dale Tiberie- expressed concern with the emissions in his yard. Stated that past Thursday Intertek-PSI obtained the sample from his yard when the odor was really bad. He asked if township had received a report from them yet. Laura asked if we could contact Mike from Intertek-PSI to get update on the testing. Stated he still would like the township to start putting the signs up within the township. Was stated that in order for the township to put signs up on state roads it would need written permission from Penn Dot. He also expressed a need to set up a committee to continue to work on the Gas Well Ordinance stating that the Ordinance is good but not good enough. He asked the supervisor if EQT had been fined for the violations of the ordinance such as leaving the gates open. Supervisor Molish suggested sending a letter to EQT and Range resources With a copy of ordinance and reminding them to keep gates closed at all times for safety reasons. He also asked if the sidewalk could be shoveled off had a lot dirt and gravel on it from snow removal.

Walter King- Asked if there were any other permits acquired for the compressor station.

Stated that a lot of heavy trucks and equipment were being brought in to the site and a lot of work was being done late at night. Also asked about a gate being required for safety reasons on the property. Solicitor Makel Suggested creating a Livestock Ordinance to be considered at the next meeting. She also asked if the Township Building is being used as a warming center in case of emergency.
